⊖ The subject presents a high threat profile for process servers. A 2024 felony conviction for possessing a dangerous weapon in a courthouse, combined with a 2023 felony conviction for fleeing law enforcement in a motor vehicle, indicates both weapon access and active evasion behavior. A third-degree murder conviction (2019) and multiple felony drug and theft convictions further elevate concern. A minimum of two process servers is strongly recommended. Do not attempt service alone. Approach should be made in a public or semi-public setting if possible. The subject is likely under active probation supervision (Hennepin County Community Corrections), which may provide a leverage avenue.

<b>Secondary Service Address:</b> 9876 Hudson St NE, Minneapolis, MN 55418 — mother Patricia Holloway's address; subject's own address history includes this location. Viable for substitute service if mother is present and of suitable age.
<b>Tertiary Check:</b> 345 24th Ave NE, Unit 20, Minneapolis, MN 55411 — address on active professional license; may represent a workplace or care client location worth a field check.

## High-Frequency Contacts

**Patricia Anne Holloway (Mother):** Age 66 — 9876 Hudson St NE, Minneapolis, MN 55418. Suitable age for substitute service per local rules if subject cannot be personally served at that address.

**Marcus DeShawn Briggs (Associate):** Age 37 — 345 24th Ave NE, Unit 20, Minneapolis, MN 55418. Subject previously used this address; may have ongoing contact.

## Mobility Patterns

**Likely home-based:** Active Homemaker license with no fixed employer suggests the subject is primarily residence-based or travels to client locations on a variable schedule. Early morning and evening attempts at the Saint Paul address are most likely to succeed.

## Legal Leverage

**Active Probation:** The subject is likely under active probation supervision through Hennepin County Community Corrections — Adult Field Services (multiple felony sentences with 3–5 year probation terms, most recent conviction June 2024). Coordinating with the probation officer may compel a response or provide a confirmed reporting address.

## 6. Final Thoughts

➔ The primary service address of 4321 Columbia Ave, Saint Paul, MN 55104 is the strongest option — deliverable, held for approximately 3.5 years, and reported current through April 2026. Attempt early morning with at least two servers present given documented weapon access and evasion history. If primary attempts fail, 9876 Hudson St NE (mother's address) is the best secondary location, with substitute service on Patricia Holloway (age 66) as a fallback. The subject's active probation supervision through Hennepin County Community Corrections is the most significant legal leverage point and should be pursued before repeated field attempts. Key data gaps include the absence of a current registered vehicle and no confirmed workplace — obtaining current probation reporting records or contacting the licensing authority for the active Homemaker license could resolve both gaps.
